Angel in Action



The Lives We Touch

Carneice Poe understands what it means to have your world change in an instant. When she found out she had cancer, she invited the whole family over for Sunday football (it just happened to be with the Vikings) by telling them “Hey, I need you guys to come over because I need to talk to you about something.”

Her brother, whom she often calls Mr. Impatient, started asking other family members, “Is she going get married again? What is she is going to tell everyone?” He had all kinds of ideas what it could be, but when they gathered, Carneice was ready with a meal. She made sure everyone was comfortable, and then she told them she had breast cancer. She let them know she needed their support, and that she wanted to explain everything to them and answer their questions. She handed out paperwork, folders, and literature to the whole family and, as she describes it, she provided an “I have Breast Cancer 101 and I don’t want anyone to worry, because I got this” informational session on what it means to have cancer.

Carneice comes from a family of strong women, and one thing they instilled in her is pride. That pride makes it difficult for her to ask for help. It was her social worker, Michelle, who told her about Angel Foundation, and even offered to fill out the paperwork for her. Initially, Carneice told Michelle, “There’s no need, you know, I’ll be okay.” But Michelle gently reminded her it is okay to ask for help.

Now, Carneice embraces all that she went through during that time because it reminds her that she survived. She is alive, she goes out walking, and she goes to work every day. In fact, she has two jobs. She went back to her second job because she missed the interaction with people. She is planning trips and believes she will be able to take them. She is happy. Looking back, Carneice shares, “I think that was my village, so I’d like to just thank all of them.”

Profiles of Partners in Action

American Indian Cancer Foundation and UCare

Minnesota is home to 11 sovereign American Indian Nations and more than 60,000 Native American people. According to the Minnesota Department of Health, the Native American population has the highest rate of cancer incidence and the highest rate of poverty by ethnicity in the state. These findings led us to partner with UCare to test our programs in four counties outside of our normal service area and measure impact on social determinants of health that cancer patients often face, which include food access, housing, and transportation. We are currently working to provide more expansive support to the Native American community in partnership with the American Indian Cancer Foundation (AICF) and our programs will now be accessible to Native Americans throughout the state of Minnesota.

Minnesota Oncology

In 2001, Minnesota Oncology Hematology, now Minnesota Oncology, provided \$65,000 in seed money to set up Angel Foundation. Margie Sborov, Angel Founder and patient advocate for more than 16 years, often met patients facing severe financial and emotional worries. At that time, she had few resources to offer. Patients were making painful decisions: "Should I cut my medication in half so I can pay rent?" "Should I pay for my clinic visits or buy food?" It was through this partnership that Angel Foundation's Emergency Financial Assistance program was created. Over the past twenty years Angel has provided more \$11 million dollars to help with non-medical basic needs to 35,000 patients and Minnesota Oncology continues to be one of Angel Foundation's longest and strongest partners.

Open Arms of Minnesota

In 2021, Angel Foundation began taking a closer look at how food insecurity is impacting our clients facing cancer. We have seen a dramatic increase in the need for food. In June, we implemented the Meals in Motion program to ensure Angel families had more healthy food options. Through a partnership with Open Arms of Minnesota, our clients now have the option to receive medically tailored meals (14) at a time for 8 weeks. Nutritious meals help make our clients' treatments more effective, so they can focus on their health and recovery. We chose Open Arms of Minnesota as a partner because of their vast experience with cancer patients. To date, we have provided 6,429 meals to cancer patients, with Open Arms of Minnesota providing meals for the caregiver and dependents in the family. Through collaborations like this, we can serve our patients in an even greater way.

Emergency Financial Assistance supports adult cancer patients by relieving some of their immediate financial concerns. These financial grants help with basic, non-medical bills such as rent or mortgage, utilities, food, and fuel. Grants provide comfort and peace of mind during the overwhelming months of diagnosis and treatment.

Financial Cancer Care connects cancer patients with a social service professional and a Pro Bono Certified Financial Planner™ through workshops and one-on-one meetings, with the goal of providing education and decreasing anxiety about managing finances as individuals and families navigate the effects of cancer-related financial toxicity.

Adult and Family Programs — Facing Cancer Together provides education and support to children, teens, and young adults who have or have had a parent or loved one with cancer by offering innovative activities to help relieve fear and anxiety about the cancer experience, reduce stress, and learn new coping skills. It also helps children and families build a support network of others experiencing similar situations. Programs include AngelPack backpacks, summer camp, family retreats, monthly activities, and more.

Angel Foundation serves the eleven-county metro which includes Anoka, Carver, Chisago, Dakota, Hennepin, Isanti, Ramsey, Scott, Sherburne, Washington, and Wright.






